**If the Ethernet address is changed when purchasing a new computer, the above-mentioned computer data must be made known in writing within 24 hours.**

The ISH connection should enable students to access INNET, which is part of the INTERNET, from ISH. INNET, the university's data network, supports the university in fulfilling its tasks. This also applies to access to the INTERNET, which results in fundamental differences to an Internet connection via a commercial Internet provider, both in terms of the permitted circle of users and the permitted use.

Only persons with UNI Innsbruck's user permit may use the INNET and INTERNET services. The allocation of data network addresses and names is carried out exclusively by UNI Innsbruck.

### Requirements:

- valid user ID with modem access authorisation of UNI Innsbruck
- single workstation computer configured with DHCP

The user regulations and the INNET user regulations of the ZID shall apply mutatis mutandis and as far as applicable, provided that nothing to the contrary is stipulated here or a written supplementary agreement exists.

The systems must be kept up to date, e.g. with regard to **Microsoft security updates** and current **antivirus software**. Contaminated computers must not be connected, as they also endanger the functioning of other devices and the data network (see consequences in case of misuse).

In order to prevent unnecessary obstruction of other users and problems with the provider, **the "fair use principle"** must be observed.

**In particular, this is prohibited:**

- to call up or send prohibited, pornographic, violence glorifying or racist contents
- the downloading of content or activities that interfere with the copyrights and/or rights of use of works of third parties
- commercial use
- a private use that goes beyond a "normal" level or results in a significant use of resources
- the operation of servers for access from the Internet
- the passing on of the services to third parties
- the provision of network services to third parties
- the passing on of personal access data to third parties
- the creation of access to the ISH student network from outside the ISH (e.g. via telephone network)
- Violations of the netiquette.
- Installation and operation of **routers and wireless LAN** as well as setting up computer networks among each other

**Abuse:**

In the event of misuse, i.e. non-compliance with the user regulations, the International Student House can prevent network and Internet access for individual devices or for all devices, **i.e. block access**.

The ISH does not assume any guarantees or liability with regard to the services and their continuous availability, nor any liability for defects in hardware and software caused by incorrect operation or use of the service offered, in particular no liability for the accuracy of the statements and information provided by the ISH advisors (see also Home Statute).
